- ❖ All incoming students must meet with an admissions specialist to register for a program.
- ❖ The documents needed to register for a program:
 - Official transcripts from high school, GED®, and college
 - Scores from the Wonderlic, TABE, SAT, or ACT (Scores must be less than two years old. Certain recent Florida graduates may use their high school transcripts in place of test scores for many- but not all - programs.)
 - Documents to confirm residency status for tuition purposes. (Dependent students, i.e. those under 24 years of age, must get documents from a parent or legal guardian.) See www.FortMyersTech.edu for details.
 - Photo ID
 - For non-US citizens INS immigration forms, such as the permanent resident card
- ❖ A \$40 non-refundable Application Fee is due at registration. Students who need to remediate to improve their TABE scores and re-test will need an additional \$30. Cash, checks and cards are accepted.
